### Reason for Roster Replacement

**Note:** A player may not be added to any roster if that player:

- a.) has already shot with another team during the current season.
- b.) has previously shot in a division higher than the one to which this team has been assigned.

All properly registered players, in order to be eligible for playoff competition, must play in a minimum of 4 regular season matches.

# ROSTER CHANGE INFORMATION

Roster changes should only be made if a hardship case exists. Each captain is responsible for making sure that their submitted roster has been verified by contacting each team member and insuring their commitment to play prior to submitting the completed roster. Changes in the completed roster should only be made if the team falls below the required minimum number of players (6 players in Fall & Spring seasons, 4 players in Summer season) which results in a hardship situation for the remainder of the season. Note the following Rule #4 in your league handbook and rules of play:

## Rule 4. ROSTER CHANGES

Roster changes may only be made during the regular 10-week season under the following conditions:

- A. A **HARDSHIP CASE** must exist. That is, a team's roster has fallen below the minimum number of players required.
- B. The roster change **MUST** be submitted **IN WRITING** to the League Office (even if a telephone call was made).
- C. A player may not be added to a team roster if that player has previously shot in a division higher than the division to which that team has been assigned.
- D. **UNDER NO CIRCUMSTANCES** may a player be added to a team's roster if he/she has already shot in any match with some other team during that season.
- E. All properly registered players, in order to be eligible for playoff competition, must play in a minimum of 4 matches.

Remember, roster changes are only allowed to help those teams that fall below the required minimum number of players so that they may continue playing during the season with the proper number of players in order to remain competitive and avoid any forfeits. Roster changes should be kept to an absolute minimum. Communication with potential players for your team before submitting the original roster is the best assurance in avoiding changes later.
